# Deposits & Payments

A \$250.00 per person non-refundable deposit is due by credit card at the time of making your reservation. Final payment is due July 10, 2023 and may be made by credit card or by check payable to Covington Travel.

# **Cancellations & Refunds**

All cancellations are subject to a \$25 per person administrative fee. For refund of all monies paid less administrative fee, a notice of cancellation must be received by Covington Travel no later than July 21, 2023. Other cancellation fees apply as follows:

Cancellation at any time after deposit is paid	\$250 per person
Cancellations received July 22-August 5, 2023	25% of total fare
Cancellations received August 6-19, 2023	50% of total fare
Cancellations received August 20-September 18, 2023	75% of total fare
Cancellations received on or after September 19, 2023	No refund

**Cancellation insurance** is available and always recommended. If plan is purchased within 15 days of initial cruise deposit, pre-existing medical condition exclusions are waived when full trip cost is insured. Traveler must be medically fit to travel at the time of plan purchase. Cancel for any reason is recommended.

# **Travel Documents**

Passenger names on travel documents must match the names on personal identification. Name changes after reservations are made may incur fees.

Guests must be fully vaccinated for Covid-19 and must carry their Covid-19 Vaccination Record Card with them.

# Personal Identification

Passengers must carry a U.S. passport valid for six months beyond the end of travel dates.
